It may be noted that a list of the applications received within stipulated last date of receiving the hardcopy of application i.e. 15.12.2016 was notified vide this Institute notification of even no. dated 08.02.2017 wherein it was specified that the applications received within the stipulated last date would only be placed before the duly constituted Screening Committee for further scrutiny as per rules. Accordingly, only the hardcopy of applications received within last date for all the Post Codes have been scrutinized and evaluated as per the stipulated age and essential educational qualification, experience and involvement in technology development/translational research criteria as mentioned in the advertisement.

As per extant CSIR guidelines and as per the advertisement, it has been decided by the duly constituted Screening Committee to give due weightage to the candidates having experience in product development / technology innovation / translational research/Applied technology etc. during the further screening process.

The following screening criteria (SC) have been adopted by the Screening Committee for recommending the candidates to be eligible / ineligible. The description for such recommendation have been given in form of relevant Codes as enumerated below.

CODE	DESCRIPTION
SC-1	Above prescribed Age Limit (Overage), hence ineligible.
SC-2	Does not meet Essential Educational Criteria, hence ineligible.
SC-3	Does not meet Essential post qualification experience criteria, hence ineligible.

SC-4	Incomplete applications (i.e. without photograph, unsigned application, application fees, applicable testimonials in support of Date of Birth, Qualification, Experience, Caste etc.), hence ineligible
SC-5	Application not received through Proper Channel from the employees of Govt. Dept., hence provisionally eligible [Ref. para 5(k) of the Advt. No. 05/2016]
SC-6	Discipline mis-match vis-à-vis advertised essential qualification. Additional clarification required, hence provisionally eligible.
SC-7	No sufficient proof of essential qualification / post qualification essential experience / DOB certificate attached. Substantiation of claim required, hence provisionally eligible.
SC-8	Does not belong to the category for which post is advertised, hence ineligible.

There are provisionally eligible candidates under SC-5, SC-6 and SC-7 categories, attached as Annexure - II who are required to submit documentary evidence in support of their candidature **within 03.04.2017**.


The applications under Annexure - I and Annexure - II will be further scrutinized based on the information / documents received from the candidates in support of their claim, as stated above.

A list of the candidates whose applications were screened and found to be ineligible based on the advertised essential criteria is attached as annexure - III.

The Screening process of the applicants has been carried out on the basis of the information furnished in the online Application Form and subsequent hardcopy of the applications. At any stage during the screening / selection process if it is detected that they are not eligible for the post(s) for not possessing the required qualification, experience, over aged or not belonging to the category to which they claim, their candidature may be summarily rejected without assigning any reason.
