## सूचना / NOTICE

## Sub: Recruitment of Technical Officer (Gr. III) under CSIR-CMERI Advt. No. 05/2018 - reg.

Attention of all concerned is hereby invited to this Institute notice of even number dated 17.05.2019 regarding recruitment of Technical Officer (Group III) under CSIR-CMERI Advertisement No. 05/2018. Further to that, the following are brought to the notice for information of all concerned.

As per the said notice the candidature of only those applicants whose hard copy of applications were received within the prescribed last date i.e. within 15.11.2018 were to be considered by the Institute and others to be rejected. Accordingly, the Screening Committee scrutinized the applications under post codes **180502**, **180503 & 180504** whose hard copies were received within stipulated time with respect to the eligibility criteria as stipulated in the advertisement No. 05/2018 of this Institute. *It may be mentioned here that the Screening of applications under the Post Code 180501 against the Advt. No. 05/2018 is under process, the outcome of which will be notified in due course.* 

The following Codes have been used during the screening process for recommending the candidates to be provisionally eligible / ineligible for Trade Test. The basis for such recommendation have been given in form of relevant Codes as enumerated below.

It is notified that the applicants found provisionally eligible at this stage would be required to appear for the trade test in r/o their respective trades, detailed scheduled of which would be notified shortly. The candidates qualifying in the trade tests would be eligible to be called for a competitive written test, details of which would be notified later. The final merit list of the candidates would be prepared based on the performance of the candidates in the said written test. The Trade Test is qualifying in nature in order to shortlist candidates for the Competitive Written Examination. The final merit list will be drawn as per the performance of the candidates in the Competitive Written Examination. Detailed scheme and syllabus of the Trade Test and Written examination would be notified shortly.

It may be noted that the Screening process of the applicants has been carried out on the basis of the information furnished in the Application Form and the documents furnished by the candidates. If at any stage during the screening / selection process or even after their joining to the post, it is detected that they are not eligible for the post for not possessing the required qualification, over aged or not belonging to the category to which they claim or furnished incomplete / inappropriate information in their application, their candidature may be summarily rejected without assigning any reason and appropriate action may be taken in this regard.
