## सूचना / NOTICE

**Sub: ENGAGEMENT OF PROJECT ASSOCIATE / PROJECT-JRF / PROJECT ASSISTANT (TEMPORARY) UNDER CSIR-CMERI ADVT. NO. 02/2020**

It is for information of all concerned that applications were invited by CSIR-CMERI for the position of Project Associate/Project-JRF/Project Assistant in response to the Institute Advertisement No. 02/2020 and subsequent Addenda and Corrigendum of even no. dated 09.07.2020, 14.08.2020 and 28.08.2020 respectively under different Post Codes. As per the stipulations of the advertisement, the eligible candidates were required to submit online applications through the Institute's dedicated email id i.e. [temprct@cmcri.res.in](mailto:temprct@cmcri.res.in) within 12.07.2020 at 23:59 Hrs.

As per the said Advertisement, the candidature of only those applicants whose soft copies of applications were received through the Institute's dedicated email id within the prescribed last date i.e. 12.07.2020 at 23:59 Hrs. were to be considered by the Institute and others to be rejected. Accordingly, the Screening Committee scrutinized the applications whose soft copies were received within stipulated date & time with respect to the educational qualification, experience, age, etc. of the candidates.

The following Codes have been utilized during the screening process for recommending the candidates to be ineligible. The reasons for such recommendation have been given in form of relevant Codes as enumerated below.

**SC-1 : Overage, hence ineligible**

**SC-2 : Not fulfilling advertised Essential Qualification, hence ineligible**

**SC-2(i) : Does not have GATE / NET / A selection process through National level examinations conducted by Central Govt. Dept. and their Agencies and Institutions.**

**SC-2(ii) : Does not have required post qualification experience**

**SC-2(iii) : Does not meet Essential Educational Criteria in relevant areas / disciplines**

**SC-3 : Application incomplete, hence ineligible**

**SC-3(i) : Unsigned Application**

**SC-3(ii) : Application without prescribed format / Form**

**SC-3(iii) : Incomplete applications (i.e. without relevant testimonials in support of Date of Birth, Qualification, Experience etc.), hence ineligible**

**SC-4 : Application received after the stipulated time limit i.e. 12.07.2020 at 23:59 Hrs., hence ineligible.**

Accordingly, the list of the candidates considered eligible on the advertised essential criterion like educational qualification, age, experience, etc. have been shortlisted for interview. The list of such shortlisted candidates is given in **Annexure - I**. The list of the candidates who have been found ineligible during the screening process as per the advertised essential eligibility criteria have been given in **Annexure - II**. It may be noted by all concerned that the advertised position of Project Associate-II in respect of the Post Code No. **P-3903** under the Project No. SSP-229412 has been **cancelled** which was already notified vide Institute's corrigendum of even No. dated 28.08.2020.

The Screening Committee has considered the candidature of the applicants on the basis of the information furnished and relevant documents attached by them in their Application Form (soft copies) received through email within stipulated time and recommended all those candidates whose applications were found in order as per the prescribed format and who fulfill the essential advertised eligibility criteria for a particular post against which one has applied. The committee also recommended that at any stage during the screening / selection process, if it is detected that they are not eligible for the post for not possessing the required qualification, experience, over aged, their candidature may be summarily rejected without assigning any reason.

The Selection Committee meeting (interview) for the shortlisted candidates would be held through online mode via **'Skype' or any other online platform, tentatively in September, 2020**. The particular online platform, exact date, detailed schedule and instructions of which would be notified on the Institute website shortly. Further, all the subsequent information / notification / corrigendum / addendum regarding this recruitment drive will be hosted on the Institute's website only. No interim inquiries will be entertained. Hence, applicants are requested to follow the Institute website i.e. [www.cmcri.res.in](http://www.cmcri.res.in) for updates.
