With reference to this Institute's Notice of even no. dated 07.05.2025 regarding the Institute's Advertisement No. 02/2025 for recruitment to the position of Junior Secretariat Assistant (Gen/S&P/F&A) and Competitive Written Examination held in a single session on 25.05.2025 thereof, this is for information to all concerned that based on the performance in Paper - I of the Competitive Written Examination, total 680 (Six Hundred Eighty) candidates are found eligible to be called for the Proficiency Test (Computer Typing Speed Test).

2. The category wise Threshold Marks (Cut off Marks) in percentage (%), as decided by the Competent Authority, to shortlist the candidates to be called for the Proficiency Tests (Computer typing test) are given below:

Category	Minimum Threshold (cut off Marks (%) in Paper -I
UR	50%
OBC & EWS	45%
SC	40%
ESM	35%
PWD-VH	30%

3. The list of the shortlisted candidates for the Proficiency Tests (Computer typing test) is given in **Annexure-I** to this notice.
4. The Scheme of the proficiency test in computer typing and criteria for Evaluation of Type-scripts of (Proficiency) typewriting test has already been indicated in the Advertisement, available in the Instt. website. The choice of medium of Typing/ Proficiency Test given by the candidate in the online Application Form has been treated as final and no request for change in the medium of Proficiency Test will be entertained.
5. **The Proficiency Test will be conducted tentatively in the Month of August, 2025 at Kolkata.** The Intimation regarding exact Date, Venue and detailed instructions for the Proficiency Tests will be notified shortly. All the eligible candidates are advised to visit Institute's website regularly for further notification in this regard.

7. Candidatures of all the applicants are purely provisional. At any stage during the selection process or even after their joining to the post if it is detected that they are/ were not eligible for the post(s) for not possessing the required qualification, over aged or not belonging to the category to which they claim, incomplete / inappropriate application, their candidature may be summarily rejected without assigning any reason and appropriate action may be taken in this regard.
8. It is reiterated that as per the scheme of the Written examination, as notified in the Advt. No. 02/2025, the Paper-I is qualifying in nature. Proficiency Test (Computer Typing Test) in computer will be taken for those candidates who secure minimum qualifying marks (determined by the Selection Committee) in Paper-I. Further, merit list will be prepared based on marks obtained in Paper-II for those candidates only, who qualify the proficiency test in computer typing.
9. **Further communication on the subject would be notified only in the Institute website.** Therefore, the candidates are advised to visit the Institute official websites i.e. **www.cmeri.res.in** regularly for any update.
