Further to this Institute notice of even number dated 16.06.2021 this is for information of all concerned that the Selection Committee meeting for recruitment of Scientists / Sr. Scientists has been scheduled as given below.

Post Code wise and candidate wise detailed schedule of the Selection Committee meeting has been enclosed herewith as Annexure – I. Further, following are hereby notified for general information of the concerned candidates:

- 1) Documents of the candidates will be verified prior to interview. Therefore, they must bring with them original certificates and a set of attested / self-attested photocopy of each in support of educational qualification, experience, date of birth, caste (wherever applicable) etc. and an identical passport size photograph used at the time of application, failing which they will not be allowed to appear for the interview. In case of OBC certificate, it should be valid for Non Creamy Layer as per the extant guidelines of Govt. of India.
- 2) Considering the present COVID-19 related situation, candidates are requested to adhere to the COVID appropriate behavior especially the following strictly:
 - i) Candidates are required to adhere to social distancing norms/guidelines to ensure his/her own safety & health of other fellow candidates.
 - ii) Candidates are requested to bring your own mask, face shield, sanitizer, gloves etc. to the Venue.
 - iii) Candidates need to follow discipline & practice social distancing during entry / exit at the interview venue as well as at the time of Interview.
 - iv) Candidates are requested to report to the Interview Venue well in advance as thermal scanning will be carried out.
 - v) No candidates will be allowed without updated RTPCR negative report (of the test conducted within 72 Hrs.).
- 3) In case a candidate is employed in Govt./PSU/Autonomous Body 'No Objection Certificate' from the employer in the prescribed proforma as per Annexure IV notified vide Institute notice dated 16.06.2021 has to be invariably produced by the candidates at the time of documents verification prior to interview, failing which such candidates would not be allowed for interview.
- 4) Percentage of marks as claimed by the candidates in their applications have been taken into consideration during the screening process. Valid and authenticated proof of percentage of marks of their academic degrees and experience claimed are required to be furnished by the candidates during 'document verification process'. Candidates are advised to present the official document of their University / Institute for conversion of the CGPA/SGPA/OGPA/DGPA grades. etc. to percentage and vice versa. In case their claimed qualification, percentage of marks, experience, age etc. in their application are not ascertained, such candidates will not be allowed for interview.

Outstation candidates will be reimbursed to and fro single Sleeper Class Rail fare (by Mail or Express) by the shortest route, from the place of undertaking the journey or from the present address given in the application, whichever is nearer, for attending the interview on production of proof of journey. Reimbursement of TA would be allowed only to the eligible outstation candidates appearing in the interview. Such candidates are advised to furnish their bank details i.e. A/c No., Name and address, IFSC Code etc. at the time of interview. The TA claims, as per rule, would be transferred electronically in their bank account subsequently.

- As per the provisions of para 4(d) of the advertisement, in case a candidate is staying abroad, his/her candidature may be considered in absentia by the Selection Committee on written request with production of a valid proof of their staying abroad. Accordingly, such candidates may furnish their valid Skype ID / IP address for Video Conferencing, working telephone / Mobile Number of abroad etc. together with the copy of their passport / visa particulars to ascertain their stay abroad to the email recruit@cmeri.res.in for being considered in absentia by the Selection Committee latest by 18.07.2021.
- 7) Further, considering the present COVID-19 related situation, those candidates, found positive as a result of the RTPCR Test conducted within the 72 Hrs. from the date of interview, may request for his/her interview through VC / in absentia, for which the willing candidates are required to send their request along with COVID-19 positive RTPCR report, their valid Skype ID / IP address for Video Conferencing, working telephone / Mobile Number etc. for consideration to the email recruit@cmeri.res.in.
- 8) The scheduled interview is likely to be continued till late evening or next day depending upon the circumstances. Therefore, the candidates in their interest, are advised to make their own arrangement for stay, travel etc. accordingly.
- 9) The call letters are being dispatched to the shortlisted candidates for interview to the addresses given in their Application Form by Speed Post. The candidates who do not receive their call letter may report to the AO (Recruitment), CSIR-CMERI at 08:00 AM on the scheduled day of interview at the interview venue itself i.e. at CSIR Vigyan Kendra (CSIR Science Centre), Lodi Garden, Gate No. 2, KK Birla Lane (Opposite India International Centre Annex), New Delhi 110003 with their original certificates and a passport size photograph used in the application form for issue of duplicate call letters.
- 10) It may further be noted that the Screening process has been carried out on the basis of the information / relevant documents in support of the candidature of the candidates received within stipulated time wherever applicable. The short listing of candidates for interview does not confer any right upon any candidate for appearing in the interview. They will be allowed for interview only if they fulfill the advertised criteria and furnish the required testimonials at the time of documents verification. Further, at any stage during the screening / selection process and even after joining, if it is found that they are not eligible for the post(s) as per the stipulated criteria and / or CSIR / GOI rules or guidelines their candidature may be summarily rejected without assigning any reason and appropriate action may be taken against them as per rules.
- 11) Any change in Date, Venue of the interview & other related guidelines owing to the prevailing situation of COVID-19 will be notified accordingly in CSIR-CMERI website only. Therefore, candidates are advised to visit our official website i.e. www.cmeri.res.in on regular basis.
