List of provisionally selected candidates for recruitment to the post of Junior Sub: Secretariat Assistant (Gen./ F&A/ S&P) under CSIR-CMERI Advt. No. 02/2025 -reg.

Online applications were invited from eligible Indian citizens for filling up of 16 vacancies of Junior Secretariat Assistant (Gen/ F&A/ S&P) under CSIR-CMERI Advertisement No. 02/2025 dated 14.02.2025.

- 2. The candidates who applied their online application successfully were invited for the Computer Based Written Examination (CBT). The CBT was conducted on 25.05.2025 in single sitting at different examination Centres as per the extant CSIR rules and guidelines.
- 3. The result of the Competitive Written Exam (CBT) including the minimum threshold marks in Paper-I, (as determined by the Selection Committee), was declared vide this Institute Notification of even number dated 22.07.2025.
- 4. A total 680 (Six Hundred Eighty) candidates who secured the minimum qualifying marks in Paper-I were called for the Proficiency Test (Computer Based Typing Test). The list of such candidates was published vide this Institute Notification of even no. dated 22.07.2025.
- 5. The Proficiency in Computer Typing Speed Test of the concerned candidates was held during 25th to 27th, August, 2025 as per extant CSIR rules and guidelines. A total no. of 595 candidates appeared in the said Proficiency Test. A list of the candidates found qualified in the said Proficiency Test is given in Annexure-I.
- 6. Subsequent to qualifying the Computer based typing speed test and based on the performance in Paper-II of the Written Examination (CBT) of the concerned candidates, the Director, CSIR-CMERI, on the basis of recommendations of the Selection Committee constituted as per the provisions of CSIR-ASRP Rules, 2020 (amended from time to time), has been pleased to approve the selection (provisionally) of the following candidates (in order of merit) for appointment to the post of Junior Secretariat Assistant (Gen. / F&A / S&P) in Pay Matrix Level-2 advertised vide CSIR-CMERI Advertisement No. 02/2025.

- 7. As per CSIR Letter No. 5-1(211)/2014-PD dated 30.05.2023, the Methodology of resolution of tie in marks between two or more candidates securing equal aggregated marks, if any, was taken into consideration. (Refer. CSIR-CMERI Advt. No. 02/2025).
- 8. Merit of the candidates vis-à-vis their order of Cadre preference mentioned by them in their application form i.e. JSA (Gen./ F&A/ S&P) and the available cadre & category wise vacancies as per the Advertisement, have been taken into consideration while allotting the Post / Cadre to a candidate. The cadre so allotted shall not be changed in ANY CIRCUMSTANCES.
- 9. As the candidature and testimonials of the candidates have not yet been verified, the status of the candidates in the above selection list remains provisional. Accordingly, all the provisionally selected candidates are hereby requested to report on 10th December, 2025 (10:30 AM sharp) at M. M. Suri Hall, CSIR-CMERI, M. G. Avenue, Durgapur 713209, West Bengal personally along with their original testimonials and documents required as per the Advt. [Documents in support of 10th / Matriculation certificate (bearing DOB), 10+2 / XII certificate or its equivalent, Category (SC/ST/EWS/OBC(NCL)/ESM/PwBD in proscribed format as per the Advertisement on the closing date prescribed for online application.), wherever applicable, NOC from current employer in case of the Applicants working in Government Departments, Photo bearing Identity Card viz. Passport, Voter Card, Driving License, Aadhar Card, PAN Card etc. and/or any other documents, in support of claims made by the candidates in the Online application | and a self-attested photocopy of each document for verification of their candidature. No request for change in date and time of DV will ordinarily be entertained.

- 10. It should be noted here that Biometric credentials i.e. thumb impression and photograph of the candidate would be again verified at the time of document verification as scheduled above. With regard to this, please note the following:
  - (a) If fingers are coated (stamped ink/ mehndi/ coloured. etc.), ensure to thoroughly wash them so that coating is completely removed before the day of verification.
  - (b) If fingers are dirty or dusty, ensure to wash them and dry them before the thumb impression (biometric) is captured.
  - (c) Ensure fingers of both hands are dry. If fingers are moist, wipe each finger to dry them.
  - (d) If the primary finger (thumb) to be captured is injured/damaged, immediately inform the concerned authority at the venue.
- 11. If any of the candidates enlisted above as a provisionally selected candidate does not appear for the said verification on the scheduled date & time, it will be presumed that he/ she is not interested to join the said position at this Institute and his/ her candidature for the said post against the Institute Advt. No. 02/2025 will be treated as cancelled and no further correspondence in this regard will be entertained by this Institute.
- 12. After successful completion of documents, biometric data & photo verification, a final select list will be published and the provisional offer of appointment to the concerned selected candidates would be issued accordingly. It should be noted that the final list of the selection would be notified strictly subject to the candidates being found eligible for the post in respect of educational qualification, age, category etc. and the decision of the Director, CSIR-CMERI would be final and binding on the matter.
- 13. The Selection of candidates in the above list is **PURELY PROVISIONAL**, subject to the document verification and fulfillment to all the eligibility criteria & conditions stipulated in the advertisement. In case it is found at any stage, that the candidate does not fulfil any of the conditions of eligibility or any information provided by them is found to be false or is not in conformity with the eligibility criteria mentioned in the Advertisement/ subsequent web notifications published by CSIR-CMERI or found ineligible on other grounds, the candidature of such candidates will be summarily cancelled / terminated at any stage, even after appointment/ joining without any further notice and appeal against such cancellation/ termination will not be entertained.
- 14. While every care has been taken during the preparation of result, CSIR-CMERI reserves the right to rectify errors & omissions, if any, detected at any stage.

Those candidates who have qualified in Paper-I of the Written Exam can only be able to check the scores of Paper-II and the remaining can be able to check for Paper-I only.
