Sub: Result of the Competitive Written Examination held on 07.11.2020 for the trades 'Welder', 'Turner', 'Motor Mechanic / Diesel Mechanic / Driver Cum Mechanic / Mechanic (Tractor)', 'Fitter', 'Sheet Metal Worker' and 'Mechanical Draftsman' against different post codes for the post of Technician-I (Gr. II) under CSIR-CMERI Advertisement No. 02/2018 – reg.

This is for information of all concerned that subsequent to their qualifying the Trade Test as notified vide Notice of even Number dated 24.6.2020 and based on performance in the Competitive Written Examination for the trades 'Welder', 'Turner', 'Motor Mechanic/Diesel Mechanic/Driver Cum Mechanic / Mechanic (Tractor)', 'Fitter', 'Sheet Metal Worker' and 'Mechanical Draftsman' held on 7th November, 2020 at CSIR-CMERI, Durgapur against different post codes for recruitment of Technician-I (Gr.-II) in response to CSIR-CMERI Advertisement No. 02/2018, the provisional list of selected and wait-listed candidates (post code wise) is attached at **Annexure** – **I.**

As the candidature and testimonials of the candidates have not yet been verified, the status of the candidates in the mentioned list of selected and wait-listed candidates remains provisional. Accordingly, all the provisionally selected candidates only are hereby requested to report on 22nd December, 2020 (10:30 AM sharp) at M. M. Suri Hall, CSIR-CMERI, M. G. Avenue, Durgapur – 713209, West Bengal with their original testimonials along with a self-attested photocopy of each document for verification of their candidature.

As a precaution for COVID-19, all candidates will be required to mandatorily undergo thermal scanning and sanitization. No candidates will be allowed without wearing mask and updated 'Aarogya Setu' App at the entry point of the Institute.

It may be noted that Biometric credentials i.e. thumb impression and photograph of the candidate would be again verified at this Institute on 22.12.2020. Accordingly, all such provisionally selected as well as wait-listed candidates are advised to note the following:

- (a) If fingers are coated (stamped ink / mehndi / coloured etc.), ensure to thoroughly wash them so that coating is completely removed before the exam day.
- (b) If fingers are dirty or dusty, ensure to wash them and dry them before the finger print (biometric) is captured.
- (c) Ensure fingers of both hands are dry. If fingers are moist, wipe each finger to dry them.
- (d) Proper sanitization is required to be maintained before & after thumb impression.

Offer of provisional appointment to the eligible candidates would be issued after fulfilling the advertised criteria during verification of their testimonials at the Institute.

In case, any of the selected candidate fail to report for joining service within the stipulated date or resigns from service after joining within the validity period of the panel as per GOI/CSIR guidelines in this regard, the eligible wait -listed candidate will be called for verification of testimonials etc.



The merit list of the candidates has been prepared only on the basis of marks obtained by the candidates in Paper-II & Paper-III in the competitive Written Examination and category wise vacancies, as per the advertisement and subsequent notifications.

It is informed that the provisional list of the selected and wait-listed candidates have been prepared keeping in view the documents and information furnished by the candidates in the Application Form. It does not confer any conclusive right on the candidates to claim eligibility for the post. If at any subsequent stage it is discovered that the candidates do not fulfill the eligibility criteria or information furnished by any candidate proves to be false or if he/she is found to have wilfully suppressed any material information, his/her candidature/appointment may be cancelled and he/she will be liable for removal from service after joining at any stage and such other legal/penal action as may be deemed necessary, may be taken by the Competent Authority. The decision of the Director, CSIR-CMERI will be final and binding in the matter.

It is also notified that one position under PWD-OH category against post code 180205, one position under SC category against post code 180209 and one position under SC category against the post code 180216 of Mechanical Draftsman Trade stands cancelled due to insufficient eligible candidates against the respective post codes.

The Candidates who appeared in the trade test and Written Competitive Examination for the trades <u>'Fitter' and 'Welder'</u> against the post code <u>180208</u>, are advised to note that their final result would be declared only after completion of the Trade Test and Written Competitive Examination of the <u>'Machinist'</u> trade.

It may be noted by all concerned that the Trade Tests for the *remaining trades i.e. 'Machinist'*, *'Electrical' & 'Plumber'* against the advt. no. 02/2018 will be held shortly, the details of which will be notified in due course.

Further, all the subsequent information / notification / corrigendum / addendum regarding this recruitment drive will be hosted on the Institute's website only. Hence, applicants are requested to follow the Institute website i.e. www.cmeri.res.in for updates.






