- 4. The written examination will be conducted tentatively in the Month of October/ November; 2025. The date, Venue and detailed instructions for the Written Examination will be notified shortly. All the eligible candidates are hereby advised to visit this Institute's website regularly for further notification in this regard.
- 5. Though every care has been taken for preparation of this result and yet CSIR-CMERI reserves the right to rectify errors & omissions, if any, detected at any stage.
- 6. Candidatures of all the applicants are purely provisional. At any stage during the selection process or even after their joining to the post, if it is detected that they are/were not eligible for the post(s) for not possessing the required qualification, over aged or not belonging to the category to which they claim, incomplete / inappropriate application, their candidature/ appointment may be summarily rejected/ withdrawn without assigning any reason and appropriate action as deemed fit by the Competent Authority, CSIR-CMERI/CSIR may be taken in this regard.
- 7. It is reiterated that as per the scheme of the Written Examination, there will be three papers (Paper-I, Paper-II & Paper-III). The Paper II and Paper III will be evaluated only for those candidates who secure the minimum threshold marks (to be determined by the Selection Committee) in Paper I. The final merit list will be prepared only on the basis of the marks obtained by the candidates in Paper-II & Paper-III.
- 8. Further communication on the subject would be notified only in the Institute website. Therefore, the candidates are advised to visit the Institute official website i.e. www.cmeri.res.in regularly for any update.
