In case of holidays, the tender will be received/opened on the next working day. Earnest money in the form of demand draft should be drawn in favour of Director, CMERI. Estimated cost has been prepared based on Ministry of Labour and Employment and Market Rate. Cost of Tender documents is non-refundable & non-transferable. The contractor has to submit copies of satisfactory work completion certificate in respect of similar nature of work done in the last five years. A Civil and Electrical Contractor cannot give his consent to more then one bidder in case of composite works. Conditional tenders are liable to be rejected. By submission of a tender for the work, a tenderer will be deemed to have satisfied himself by actual inspection of the site and locality of the work, about the quality and availability of required quantity of materials and that the tendered rates will be adequate to complete the work as per specification with quantity. Tender will be rejected if white fluid is used anywhere in the Tender Document. Earnest Money is liable to be forfeited if the contractor awarded the work fails to start the work immediately and in any case within 10 (Ten) days from the date of work order.
