Earnest money in the form of demand draft should be drawn in favour of Director, CMERI. Estimated cost has been prepared based on DSR-16, WBPWD-15 and M.R. Cost of Tender documents is non-refundable & non-transferable. The contractor has to submit copies of satisfactory work completion certificate in respect of similar nature of work done i.e civil water proofing works in the last five years. A Civil and Electrical Contractor cannot give his consent to more then one bidder in case of composite works. Conditional tenders are liable to be rejected. By submission of a tender for the work, a tenderer will be deemed to have satisfied himself by actual inspection of the site and locality of the work, about the quality and availability of required quantity of materials and that the tendered rates will be adequate to complete the work as per specification with quantity.
