Engagement of Part-time Doctor (Allopathic System) at CSIR –CMERI – CoEFM, Ludhiana

CSIR-Central Mechanical Engineering Research Institute (CSIR-CMERI), established in 1958, is a premier Institute under the aegis of Council of Scientific and Industrial Research (CSIR), **desires to engage Part-time (purely on temporary basis) for its extension centre at Centre of Excellence for Farm Machinery, Ludhiana**, on payment of a monthly consolidated honorarium for OPD treatment of its employees, pensioners and family pensioners and their dependent family members. Duty Hours:	Part-Time Doctor will work for three hours per day (except Sunday and Gazetted holidays) and three days per week during the timings based on the requirements of the Institute.			
Emoluments:	Selected candidate will be paid a consolidated honorarium of Rs. 1770/- (Rupees One thousand Seven Hundred and Seventy only) per sitting of three hours per day.			

Selection Procedure: The Part-time Doctor will be selected on the basis of performance in “Walk-in-Interview”. Preference will be given to those who have desirable qualification / experience.

Candidates fulfilling the above mentioned Essential Qualification, Age *etc.*, may attend the **Walk-in Interview on 07th May, 2026 (Thursday) at CSIR-CMERI-CoEFM, Ludhiana Centre at 11:30 AM** along with application form (attached herewith) duly filled-in and photocopies of necessary certificates along with all original certificates for verification and 02 passport size colour photographs also.

Reporting Time for the candidates for Document verification will be 10:00 AM.

Job requirement and Honorarium: To perform general duties as a Part-Time Medical Officer at CSIR-CMERI - **Centre of Excellence for Farm Machinery, Ludhiana** and to attend to patients which will comprise employees, pensioners and their dependent family members and family pensioners. In case of serious ailments, if required, he/she has to refer patients to any of the Hospitals which are tied up with CSIR-CMERI – COEFM, Ludhiana for extending treatment with credit facility or without credit facility, as the case may be.

Payment of monthly honorarium is solely attendance based for the whole month and in case of absence from duty on leave beyond the entitled number of leaves or for any other reason in a particular month, the honorarium will be calculated on pro-rata basis for the period of duty performed by him/her. No other payment except the admissible honorarium based on actual attendance will be paid to the Part-Time Doctor.

General terms and conditions:

1. The date for determining age/qualification and experience shall be the date of the walk-in interview.
2. No TA/DA will be paid to the candidates for attending the walk-in interview or for joining, if selected.
3. The above position is purely temporary on Contract basis for one (01) year. Candidate engaged in this position will not have any right implicit or explicit for consideration for regularization/ absorption against any post(s) of CSIR / CSIR-CMERI.
4. **Leave:** The Part-time Doctor would not be entitled for any kind of regular leave. However, he/she will be entitled for 12 days leave in a calendar year, to be calculated on pro-rata basis.
5. **Confidentiality of data, information and documents:** The information, data and documents related to the patients shall remain confidential. No one shall utilize or publish or disclose to a third party, any part of the data or statistics or proceedings or information collected for the purpose of this assignment or during the course of assignment for the office, without the express written consent of the office. The Part-time Doctor is bound to hand over the entire set of records to the office before the expiry of the contract.
6. **Conflict of Interest:** The Part-time Doctor engaged by this office, shall not represent or give opinion or advice to others in any matter which is averse to the interest of this office.
7. Canvassing in any form and/or bringing any political influence or otherwise will be treated as a disqualification for the above position.
8. **Termination of Service:** The engagement may be terminated at any time by the office without assigning any reasons by giving a notice of 30 days. In case, a part time medical officer desires to leave the contract/job, he/she has to serve the notice before 30 days which can be curtailed/extended at the discretion of the Appointing Authority.
9. **Tax Deduction at Source:** The income Tax or any other tax liability will be as per the prevailing rules and it will be deducted at source before effecting the payment of honorarium for which the office will issue TDS certificate.
10. Eligible candidates must bring with them all Original requisite documents viz. Date of Birth, Educational Qualifications, Community, Experience(s) and PPO (in case retired from service) etc., at the time of Walk-in-Interview. In case of failure to bring the original certificate, candidates will not be allowed to appear for the interview.
11. The engagement of Part-time Doctor is subject to the terms and conditions issued by CSIR in this regard from time to time. For all intent and purposes, the services of part time medical officer will be under administrative control of the Director, CSIR-CMERI, Durgapur.

12. The decision of the Director, CSIR-CMERI, Durgapur in all matters relating to eligibility, acceptance or rejection of applications and mode of selection will be final and binding on the candidates.
13. The Candidates applying for above position must be medically fit.
