The Selection process may continue till late evening/next day, Candidates are advised to come prepared accordingly.

If it is found at any stage of the process or thereafter that the candidates do not fulfil the eligibility criteria, their candidature shall be cancelled without assigning any reason whatsoever. Further, the decision of CSIR-CMERI-CoEFM in regard to the selection process will be final and binding to all concerned. No correspondence in this regard will be entertained by the Institute.

Offer of engagement to the selected candidates will be issued subject to availability of fund and approval of the Competent Authority. Tenure mentioned in the advertisement is tentative and liable to be curtailed/extended as per decision of the Competent Authority.
